8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
Answer: No the Company undertook a significant drilling program at Paterson Central during Q1 FY2023 which continued into Q2 FY2023. Limited on ground exploration work is expected in the coming Quarter due to the need to receive and review drill data, the onset of the cyclone season in the Pilbara region and the summer holiday shut down.	
8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
Answer: The Company has investments in listed Company assets in the amount of \$0.9m. The Company will evaluate alternative capital raising initiatives in addition to potential sale of these investments, as required.

Answer: The Company announced a significant increase in the Carlow Castle mineral resource in Q2 FY2023. Yes, the Company will be able to continue operations on the basis of funds on hand, a seasonally imposed significant reduction in exploration activity and a potential to sell down its investments, and raise additional capital.
