	8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
	No. There was a significant increase in exploration and evaluation payments during the December 2022 quarter (\$1.548m) while cash used for operating activities was \$0.201m. NWM does not expect that this level of exploration and evaluation payments will continue into the current quarter.	

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Yes. The Company is considering raising further cash to fund expanded drilling programs at its Bali Copper Project and Arunta West REE Project, and will finalise a decision once assay results for its Arunta West Project have been released. The Company has a high level of confidence of successfully raising sufficient capital based on previous capital raising successes and discussion with its corporate advisers.
