# **December 2022 Quarterly Activities Report**

#### **HIGHLIGHTS**

- Moving-loop ground EM survey of Ni targets completed over highly prospective komatiite-hosted nickel sulphide mineralisation along with Platinum and Palladium anomalies over a 3.6km strike length <sup>1</sup>
- 63 holes RC for 3530m were drilled to test structural targets generated from Sub-Audio Magnetics (SAM) survey and UFF soil sampling programs were completed with assay results expected in Q1 2023 <sup>2</sup>
- Assay results from the drilling program and interpretation of the MLEM are expected in Q1 2023.

Western Gold Resources Limited (ASX: WGR) ("WGR" or "the Company") is pleased to provide shareholders with its quarterly report for the three-month period ending 31 December 2022.

#### **WGR Managing Director Warren Thorne commented:**

"This quarter has seen WGR complete greenfield exploration for Au and Ni based on targets generated from structural mapping, soil geochemistry programs and Sub-Audio Magnetic geophysical targets. The drilling at the Kingfisher North prospect is of particular interest as it has been previously ignored by explorers due to the Proterozoic cover. The drilling completed provides an opportunity to test the Archaean basement below the cover and the continuation of the Brilliant and Joyners Find Shear zones. WGR is grateful for the support of the Western Australian Government's Exploration Incentive Scheme in recognising the potential of the Kingfisher North prospect. The work is testament to the exploration team's work to deliver a strong pipeline of advanced exploration targets".

# **Nickel Exploration**




Figure 1. UFF+ soil geochemistry Ni-Pt Pd anomalies over TMI image

WGR completed a ground-based Moving Loop Electromagnetic (MLEM) survey to delineate drilling targets associated with 2 nickel-platinum-palladium soil anomalies (Figure 1; Big Z's and Duran's) identified by the soil sampling program within the Joyners Find Greenstone Belt at WGR's Gold Duke project (see ASX 11th July 2022).

Twenty lines of Ground based Moving Loop Electromagnetic survey (MLEM) were completed with the MLEM survey looking to define EM conductors that could represent concealed nickel sulphides. Once interpreted, priority EM conductors to be subsequently drill tested.

# **Exploration Drilling**




Fig 2. Top Knot and Kingfisher North prospects showing drilling targets and structural framework (on TMI)

A total of 63 holes RC for 3530m were drilled across the Kingfisher and Topknot prospects (Figure. 2). Assay results are pending and are expected in Q1 2023.

# **Top Knot**

The Top Knot prospect is located on the Joyner Find Shear Zone (Figure 2) and contains numerous shallow historic shafts hosted within a package of intercalated ultramafic and chert rocks. A total of 27 RC holes for 1230m were drilled to test co-incident targets

previously generated from a Sub-Audio Magnetics (SAM) survey (see ASX announcement 11 November 2021) and soil geochemistry (see ASX announcement 17 February 2022). A total of 17 holes are planned to target the intersection of NNE-trending faults and the JFSZ, interpretated to control mineralisation at the Top Knot prospect.

# North Kingfisher

A total of 36 holes for 2300m was drilled at the North Kingfisher prospect that is concealed under the Proterozoic Finlayson Member, a fine to medium grained, well-bedded arenite, with thin conglomerate intervals. The holes intercepted ultramafic, mafic and rhyodacite intrusive rocks within fault splays of the Brilliant and Joyners Shear Zones. The prospect has had no previous drilling. The drilling at North Kingfisher is co-funded by the WA Government EIS drilling grant of \$118,500.

#### **Planned Activities for the March Quarter**

WGR aims to continue its greenfield exploration program across the northern portion of the project. Work programs will include:

- A targeted AC drill program over coincident structural-geochemical targets at the Brilliant North and Bottom Camp Prospects generated from UFF soil sampling programs and Sub-audio magnetic geophysical survey interpretation.
- Follow-up of results from the Kingfisher North and Top Knot RC drilling program.
- Rehabilitation of previous drill programs at Wren, Gold King and Brilliant.
- Drilling planning for RC drilling to follow-up potential nickel targets generated from MLEM.

# Corporate

Cash

Cash on hand at the end of the guarter was \$0.71 million.

#### **Other Matters**

In accordance with the reporting requirements of ASX Listing Rule 5.3 the Company advises as follows:

- It has spent \$0.64 million on exploration and evaluation activities during the quarter. There was no mining development or production activities conducted during the quarter.
- Expenditure predominantly related to:
  - Exploration Drilling at the Gold Duke Project;
  - Soil sampling to north and south of Duran's Ni-Pt-Pd prospect and along BSZ General fieldwork.
- Comparison of Actual Expenditure to the Use of Funds Statement in the Prospectus dated 18 May 2021 and for the period since listing on 23 July 2021.

# **Competent Person's Statement**
