Answer: No, cash outflows from investing activities included the payment of drilling and related services as a result of a significant resource drilling campaigns at the Burns prospect undertaken and completed in the quarter. Lefroy Exploration Limited does not expect to have the same level of net operating cash outflows going forward, as it is not expecting to undertake the same level of drilling activity within the next 2 quarters. Lefroy Exploration Limited also completed a \$3.5m capital raise during the quarter ended 31st December 2022.

As well as factoring in the expected decline in net operating cash out flows in relation to the planned listing of Johnston Lakes Nickel Ltd, a wholly owned subsidiary of the Company.
