- ❖ Betta Group, Orcoda's subsidiary, signs a \$AUD4.1 million contract with Yurika.
- Works scheduled to support large infrastructure projects in 2H FY23.

Yurika is part of Energy Queensland and is the largest, wholly government-owned electricity company in Australia. \$4.1 million in revenue is expected to be earned and received in 2H FY23.

Yurika is building an electricity transmission line to the Olive Downs Complex, a large-scale steelmaking coal mine located in the Bowen Basin of Queensland.
