SRG Global Secures Civil and Remedial Engineering Contracts valued at ~\$40m

Highlights:

- **Multiple civil and remedial engineering contracts secured valued at ~\$40m**
- **Clients include Department of Transport Victoria, McConnell Dowell and CBGU JV**
- **Contracts in the bridge, rail and marine sectors in Victoria and Queensland**

SRG Global Ltd ('SRG Global' or 'the Company') (ASX: SRG) is pleased to announce that it has been awarded multiple civil and remedial engineering contracts in the bridge, rail and marine sectors in Victoria (VIC) and Queensland (QLD). The total value of the new works secured is ~\$40m, which include:

- Bridge maintenance works at the West Gate Bridge in VIC for the Department of Transport Victoria (DoT). Works have commenced and are expected to complete within six months;
- Bridge maintenance works at the Nine Mile Creek Bridge in VIC for the DoT. The contract has commenced and is expected to complete within two months;
- Bridge maintenance works at the Glenferrie Road over Caulfield Rail Bridge in VIC for the DoT. The contract has commenced and is expected to complete within four months;
- Bridge maintenance works at the Donnybrook Road Bridge over Barbers Creek in VIC for the DoT. The contract has commenced and is expected to complete within four months;
- Supply of products and specialist engineering services at the Cross River Rail project in QLD for the CBGU JV (CPB Contractors, UGL, Ghella and BAM). The contract has commenced and is expected to complete within eight months; and
- Wharf remediation works as part of Port of Melbourne's Swanson Dock West Remediation Project in VIC for McConnell Dowell Constructors (Aust) Pty Ltd. The contract is expected to commence in March and run for 21 months.

David Macgeorge, Managing Director, commented: "We are very pleased to be awarded these contracts to provide civil and remedial engineering services for major infrastructure assets in the transport and water sectors. These contract wins reinforce our position as a partner of choice to provide critical services for tier one clients."
