### **RESULTS OF GENERAL MEETING**

Coda Minerals Limited ("the Company") wishes to advise pursuant to Listing Rule 3.13.2 that all resolutions presented at the General Meeting of Shareholders held today were carried by a poll.

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act, the Company advises details of the resolutions and the votes received in respect of each resolution are set out in the attached summary.

The issue of 1,341,667 new placement shares at \$0.24 per share to the Directors which was approved at today's General Meeting will occur in the next few days and will raise an additional \$322,000 in addition to the approximately \$3.8 million raised (before costs) in the placement to non-related party Placement Investors at the same issue price as announced to ASX on 26 October 2022 and 7 November 2022. The placement price of \$0.24 per share represents a 0.5 cent premium to the closing share price on 7 February 2023 of \$0.235 per share.
