CLEANSING NOTICE

This notice is given by Strickland Metals Limited (**Issuer**), under section 708A(5)(e) of the Corporations Act 2001 (**Act**).

The Issuer today released an Appendix 2A for the issue of 117,968,750 fully paid ordinary shares at an issue price of A\$0.032 per Share (**Shares**) to institutional, professional and sophisticated investors who are not related parties of the Issuer under the placement announced on 3 February 2023.
