The issue relates to a \$15 million equity placement agreement with LDA Capital. In addition to the issue, the Company will pay LDA Capital a commitment fee of A\$300,000, to be paid A\$75,000 on each of the first four placements completed, with at least \$150,000 to be paid by 18 months from the date of the Agreement, and the whole amount to be paid by 2 years from the date of the Agreement (irrespective of whether any placements have been made). The Company is also responsible for legal fees relating to the Agreement, up to a maximum of US\$25,000.
