### **CLEANSING NOTICE**

**DRA Global Limited** (ASX / JSE: DRA) ("DRA" or "the Company") issued 25,264 fully paid ordinary shares ("Issued Shares") on 1 March 2023 on the exercise of zero-exercise price options by current and former Non-Executive Directors – see Appendix 2A dated 1 March 2023.

DRA advises that the *Corporations Act 2001* (Cth) ("Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or section 708A of the Act. By the Company giving this notice, a sale of the Issued Shares noted above will fall within the exemption in section 708A(5) of the Act.

  - that investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:
    - / the assets and liabilities, financial position and performance, profits and losses and prospects of the body; or
    - / the rights and liabilities attaching to the Issued Shares.
