### **NOTICE UNDER SECTION 708A(5)(E) OF THE CORPORATIONS ACT 2001 (CTH)**

IMDEX Limited (ABN 78 008 947 813) (ASX:IMD) (**IMDEX** or the **Company**) advises that it has today issued 5,480,847 new fully paid ordinary shares (**New Shares**) at a deemed issue price of \$2.37 as part payment of consideration for the acquisition of Devico AS by certain Devico vendors as announced on 19/01/2023 and 01/03/2023.

The Company hereby provides notification under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Act**) of the issue of the New Shares. The Act restricts the on-sale of securities issued without disclosure unless the sale is exempt under section 708 or 708A of the Act. - (c) as at the date of this Notice, the Company has complied with:
  - (i) the provisions of Chapter 2M of the Act as they apply to the Company; and
  - (ii) sections 674 and 674A of the Act; and
- (d) as at the date of this Notice, there is no excluded information, within the meanings of section 708A(7) and 708A(8) of the Act.
