SRG Global Secures Site Infrastructure Contracts valued at ~\$50m

Highlights:

- **Multiple site infrastructure contracts secured valued at ~\$50m**
- **Asset Care business awarded first contract win under SRG Global ownership**
- **Clients include BHP Iron Ore, BHP Nickel West, Northern Star, Albemarle Lithium and AngloGold Ashanti Australia**
- **Contracts secured in the resources sector in Western Australia**
- **\$960m of new contract wins announced since the start of FY23**

SRG Global Ltd ('SRG Global' or 'the Company') (ASX: SRG) is pleased to announce that it has been awarded multiple site infrastructure contracts in the resources sector in Western Australia (WA). The total value of the new works secured is ~\$50m, which includes:

- Supply of Asset Care non-destructive testing, condition monitoring and inspection services for BHP Iron Ore across all WA iron ore mine site, rail, road and port infrastructure. This contract extension commences in March and is for a two year period;
- Specialist earthworks, mechanical, electrical and HDPE lining associated with the construction of a tailing storage facility for BHP Nickel West. The contract has commenced and is expected to be complete within 4 months;
- Construction of a tailings storage facility at Northern Star Resources' Gidji mine site. The contract has commenced and is expected to be complete within 8 months;
- Enabling works including earthworks and civil construction of laydown area to facilitate the delivery of Trains 3 and 4 for Albemarle Lithium at their Kemerton Lithium Processing Plant. The contract is expected to commence in March and run for 6 months; and
- Aviation infrastructure upgrade to the Tropicana aerodrome in the Goldfields region of Western Australia for AngloGold Ashanti Australia Limited. The contract has commenced and is expected to be complete within 3 months.

David Macgeorge, Managing Director, commented: "These awards demonstrate SRG Global's capability and experience in delivering complex site infrastructure projects within the resource sector. These contract wins are testament to our long-standing relationships with tier-one repeat clients and continues our strong track record of opportunity pipeline conversion."
