

CORRECTION ANNOUNCEMENT

On 3 November 2022 and 17 March 2023, Raiden Resources Limited (ASX: RDN) ("Raiden" or "the Company") released an announcement that contained an incorrect drill hole intercept from the Mt Sholl diamond drill program completed in November 2022.

This correction has no material impact on the reported results as the correct nickel equivalent (Ni Eq) value was reported at the time of the announcements, however corrections to the component nickel and copper values was required.

The Company wishes to amend the following significant drill intercept:

Hole 22B2DD005¹ – 21.49m @ 1.75% Ni Eq from 32.70m (0.74% Ni, 1.08% Cu, 272ppm Co, 5.41g/t Ag & 1.11g/t 3E) (3E = combined Pd, Pt & Au values)

- **Including 8.0m @ 2.42% Ni Eq from 39m** (1.09% Ni, 1.51% Cu, 376ppm Co, 7.04g/t Ag & 1.43g/t 3E)
- **And 2.0m @ 3.14% Ni Eq from 41.5m** (1.55% Ni, 1.83% Cu, 517ppm Co, 8.80g/t Ag & 1.49g/t 3E)
