FDA Allows Manufacturing to Begin at Expanded Production Facility for DurAVR™ THV

BRISBANE, Australia and MINNEAPOLIS, USA, Anteris Technologies Ltd (**Anteris** or the **Company**) (ASX: AVR) is pleased to announce that the United States Food and Drug Administration (FDA) has determined Anteris has met the regulatory requirements for manufacturing DurAVR™ THV at the Company's newly expanded production facility in Maple Grove, Minnesota USA.

The FDA's determination will allow for expanded in-house production capabilities that will lead to significant cost savings for the Company, and increased production efficiency as we prepare to build DurAVR™ Transcatheter Heart Valves (THV) in anticipation of upcoming clinical studies.

DurAVR™ THV's produced at the Maple Grove facility will be made available to leading interventional cardiologists treating patients with severe aortic stenosis as part of the DurAVR™ THV Early Feasibility Study (EFS) and Global Pivotal Studies.

The expanded Maple Grove facility complements existing tissue engineering capabilities in Malaga, Perth, where the company's patented ADAPT® anti-calcification technology is manufactured, whilst expanding overall production capacity.

Mr. Wayne Paterson, Anteris' Chief Executive Officer, said: "The commencement of valve production for clinical use at our US Maple Grove facility introduces great efficiencies and reduces manufacturing costs and is within easy reach of the world's largest TAVR centres and cardiovascular market".
