The issue of these performance rights relates to grants under the QuickFee Limited Performance Rights and Options Plan.

Jennifer Warawa's rights consist of

- (a) two equal tranches of 750,000 rights that convert into ordinary shares subject to employment as at 28 November 2023 and 28 November 2024 (ASX has confirmed that these are "ordinary course of business securities; pursuant to section 8 of ASX Guidance Note 19 and that it does not object to their issue); and
- (b) two equal tranches of 750,000 rights: tranche 1 vests on the first date after 31 January 2023 that a 30 day Volume Weighted Average Price of the Company's shares (VWAP) of 15 cents is achieved and tranche 2 vests on the first date after 31 January 2024 that a 30 day VWAP of 20 cents is achieved, both subject to employment as at the earliest vesting dates.

The remaining 250,000 rights are issued under the QuickFee Limited Performance Rights and Options Plan to various employees, with the same conditions as (b) above.
