Operations Update

Mozambique

- US\$2.0m WBHO Contract at Temane completed by Projectos Dinamicos (PD). Final handover in progress.
- Work by PD on TSK/CTT accommodation camp contract at Temane (contract value circa \$US5.0m) progressing on schedule.
- Futuro Group (FG) entities experiencing a significant lift in business activity, with engineering recruitment and construction contract enquiries increasing as Total and EPC contractor, Saipem, prepare for imminent restart to the Rovuma LNG onshore facility in Afungi.

Labour and training specialist RBR Group Limited (**RBR or Company**) is pleased to present this operations update on its Mozambique business units.

RBR's Executive Chairman, Ian Macpherson commented: *"The Company continues to experience, and see the potential for, revitalisation and growth across its Mozambique businesses.*

Significantly, Projectos Dinamicos continues to build its revenue base with a focus on increased provision of camp accommodation and local labour supply services at the SASOL PSA project in Temane. The successful completion of works for the handover of the WBHO camp and the timely progress on the SASOL PSA camp project, notwithstanding the challenges posed by Cyclone Freddy, demonstrate PD's ability to deliver positive outcomes. The Company sees the strong performance of PD on these initial contracts as a platform from which to build in this key focus area.

Also pleasing are the signs of increased activity surrounding all aspects of a restart at Rovuma LNG. The Rovuma LNG Project is a major development project for its joint venture partners and Mozambique generally. With this world scale project looking to get back underway, opportunities for participation by RBR Group companies in Mozambique should continue to arise. The focus here will be for Futuro Group to turn what are encouraging levels of enquiry into contracted business."

WBHO contract:

PD has completed works on the WBHO camp and services project and is in the process of handover of the facility to the customer.

The completed facility includes Stores Warehouse and Offices, Mess Hall for feeding 1500 people, Ablution Block for 1500 people and Turnstile /security access containers to accommodate access control of up to 3000 people.

Works were completed on time and budget notwithstanding significant challenges as a result of flash flooding from tropical Cyclone Freddy that inundated the Central-East coast of Mozambique during February.

RADX/TSK contract:

The Temane PSA gas project developers, being a consortium of Sasol (SA), Globetech and Electricidade de Mocambique have established an operating entity Central Térmica de Temane (CTT) as the project principal contractor during development. The RADX/TSK contract was issued by CTT.

PD commenced this camp supply/construction contract for a 420-person camp and associated services facility for the TSK - CTT consortium in January to support the CTT 450mw Gas Powered Plant project. At the time of writing PD have delivered a number of individual and dormitory style accommodation units, ablution block, kitchen, and laundry facilities units. There are in excess of 100 workers involved in construction.

Flooding issues caused by Cyclone Freddy severely restricted direct access at the Temane PSA site. Notwithstanding, PD was able to utilise the infrastructure established at its wholly owned Shankara Lodge property, located within 5km of the project site, for laydown and assembly to ensure the targeted construction completion and handover schedule set for July 2023 was maintained.

Northern Mozambique LNG - Update

The February 2023 visit by Total Energies CEO Patrick Pouyanne to the Afungi peninsula sparked a new dynamic for the stalled development of the Rovuma LNG mega project. Futuro Group management have reported a significant lift in enquiries, in particularly in labour hiring across multiple skill levels.

Whilst Total is yet to make an official announcement on the lifting of Force Majeure on the project Saipem executive, Alessandro Puliti has publicly stated that July 2023 is the target for formal resumption of works.

Recent developments both in Cabo del Gado and additional port cities include:

- Increased interest and on ground activities by O&G majors to develop shore-based facilities in Pemba and or Nacala. Futuro Group have access to prime locations in both Port cities.
- Port development in Northern Mozambique continues with cargo terminal development in Pemba and Nacala. Nacala port has virtually doubled its container capacity with clear opportunities and vision for servicing the LNG developments.
- Commercial shipments of gas from Block 4 Coral Sul FLNG (3.4 mill tpa) operated by ENI continue as scheduled.
- Commercial rentals and property values lift in the capital Maputo as international contractors return.
