Answer: No, there was a higher-than-normal level of exploration spend during the quarter where a significant cash prepayment for a drilling contract has been included in this quarterly reporting period.
8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	Answer: The Company primary option for funding is to ensure the options issued as part of the 2021 listing are exercised mid-2023. Approximately \$750,000 have been taken up by investors early. If this option does not transpire, the Company is assessing option from both internal and external sources. The Company has no reason to believe any steps taken in this regard won't be successful.
