- Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No, cash outflows from investing activities in the March 2023 Quarter included the payment for drilling, assaying and related services as a result of a significant resource drilling campaigns undertaken at the Burns prospect in the prior Quarter.

Lefroy Exploration Limited does not expect to have the same level of net operating cash outflows going forward, as it is not expecting to undertake the same level of drilling activity within the next two quarters.

Factoring in the above, Lefroy Exploration Limited believes it has cash available for future operating activities in excess of two quarters of net cash outflows for relevant outgoings going forward.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Notwithstanding the above, the Company continues to review appropriate funding opportunities to pursue its exploration strategy and objectives that are in the long term interests of its shareholders.
