## COMPLETION OF PLACEMENT AND CLEANSING STATEMENT

Further to the ASX announcement on 21 April 2023, Calidus Resources Limited ('Calidus' or 'the Company') (ASX: CAI) advises that it has issued and allotted a total of 109,756,478 fully paid ordinary shares ('Placement Shares') at an issue price of \$0.21 per share to professional sophisticated and institutional investors. The Placement Shares were made up of 65,932,626 shares pursuant to the Company's 15% capacity under ASX Listing Rule 7.1 and 43,823,852 shares pursuant to its 10% capacity under ASX Listing Rule 7.1A.
