archTIS Awarded \$353,332 Contract with DHL Information Services for NC Protect and NC Encrypt

archTIS Limited (ASX:AR9, OTCQB:ARHLF), a global provider of innovative software solutions for the secure collaboration of sensitive information, is pleased to announce the Company has signed an agreement with DHL Information Services (Europe) s.r.o. (DHL) to license NC Protect and NC Encrypt.

The total initial contract value of A\$353,332, of which A\$111,430 is for annual recurring licensing revenue (ARR) across 800 users; with the ability to purchase additional licenses during the contract period. The contract term runs until 30 April 2026. The contract can be terminated for convenience but provides for payment of deliverables accepted prior to the date of termination, together with any reasonable costs attributable to the termination.

The award also upgrades DHL's legacy SharePoint offerings from cp.Protect; which was acquired by archTIS in October of 2021. This contract will upgrade their existing cp.Protect licences to NC Protect and NC Encrypt.

NC Protect with the NC Encrypt module provides encryption capabilities out-of-the-box for organisations that prefer to manage their own encryption keys as opposed to those provided by vendors such as Microsoft. Data encryption and key management are a core part of any organisation's security and compliance toolbox for protecting M365 and SharePoint data. The product offering adds additional access and data protection capabilities to the standard Microsoft Purview Information Protection and Remote Management Service controls that are enabled as part of the Active Directory domain. Combining these Microsoft controls with NC Protect allows companies to build-in dynamic policy orchestration and robust encryption for real-time protection of sensitive and business-critical data.

Kurt Mueffelmann, archTIS COO and US President, said: "We are pleased to have DHL begin to deploy archTIS' products globally. There is a significant opportunity across DHL's 400,000-employee base for NC Protect and NC Encrypt to meet data encryption, GDPR information security guidelines and achieve digital sovereignty for Microsoft 365 (M365). This award is an important milestone as we continue to expand our customer base in Europe and across the globe."
