Mr Foong is appointed to the role of an Executive Director.

Term

The appointment is till 30 January 2025. Subject to mutual consent, the term of the Appointment is renewable for a further period of three years on the same conditions unless mutually agreed to be varied.

Remuneration

Mr Foong will be remunerated at AUD \$350,000 per year.

Termination

Either party may mutually terminate this agreement in writing at any time with 60 days written notice.
