The **District Council of Peterborough** and **Magnetite Mines** are pleased to announce the signing of a Memorandum of Understanding (MOU) between the two parties in support of the Razorback Iron Ore Project, located 80km east of Peterborough. The MOU establishes a strong, collaborative commitment to the responsible and sustainable development of the Razorback Project and its interactions with local communities.

The importance of Peterborough to the Razorback Project is significant. The town is well positioned to become the Project's key service centre given its location at the western end of the mine access and transport corridor. Reflecting its historical position as the epicentre of the South Australian rail network servicing the Broken Hill mines, Peterborough once again has the opportunity to prosper in servicing the mining sector.

Magnetite Mines, with an inventory of 6 billion tonnes of iron ore resources, is primed to open up South Australia's massive, but until now undeveloped, Braemar Iron region. The production of premium-quality magnetite iron ore concentrates from the Razorback Project is key to the emergence of an entirely new "green iron" industry for the state, with green iron production hubs set to emerge in the Upper Spencer Gulf region in support of the urgent decarbonisation of the global steel sector.

The District Council of Peterborough and Magnetite Mines share the foresight to act early and establish a partnership on behalf of the local community. Building on the keen interest of the local community, the MOU formalises a common commitment to collaborate on key initiatives and maximise the social outcomes and opportunities associated with the Project.

The terms of the MOU enable broad level of strategic support for the Razorback Project with the objective of bringing together the District Council of Peterborough, Magnetite Mines and key stakeholders to:

A ceremonial signing of the MOU is to be held in Peterborough on Friday 5 May with the Hon Geoff Brock MP and Minister for Local Government, attending as a mark of this significant milestone. A community information session will follow to give local residents and businesses the opportunity to share their aspirations about the Project and learn more about Magnetite Mines development plans.

A SIGNIFICANT OPPORTUNITY FOR PETERBOROUGH

Economic impact analysis, completed by leading economic research consultants BDO EconSearch, has modelled the potential benefits arising from the construction and operations phases of the Razorback Project. The analysis predicts considerable economic contributions from the Project through the construction and operations (life-of-mine) phases on local, regional and state levels (Figure 2).

Peterborough, as the logical gateway to the Razorback Project, stands to realise significant benefits from the Project's activities with over \$290 million in additional economic activity and almost 60 jobs for over a generation. Under the MOU, the District Council of Peterborough and Magnetite Mines will seek to partner on initiatives to capture this economic development potential in a sustainable manner.
