Latin Resources Limited (ASX: LRS) ("Latin" or "the Company") refers to the attached Form 605 (Notice of ceasing to be a substantial holder) from Electrification and Decarbonization AIE LP & Waratah Capital Advisors Ltd (Waratah).

The Company notes that Waratah has increased its total shareholding in Latin from 97,791,073 shares (in August 2022) to 115,000,000 shares through on-market buying, however, due to the increase in Latin's share capital resulting from the recent placement completed on 27 April 2023, the holding was diluted to 4.5%.
