



## NOTICE UNDER SECTION 708(5)(e) OF THE CORPORATIONS ACT 2001

This notice is given by Vysarn Limited (ASX: VYS) (Vysarn or the Company) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act).
