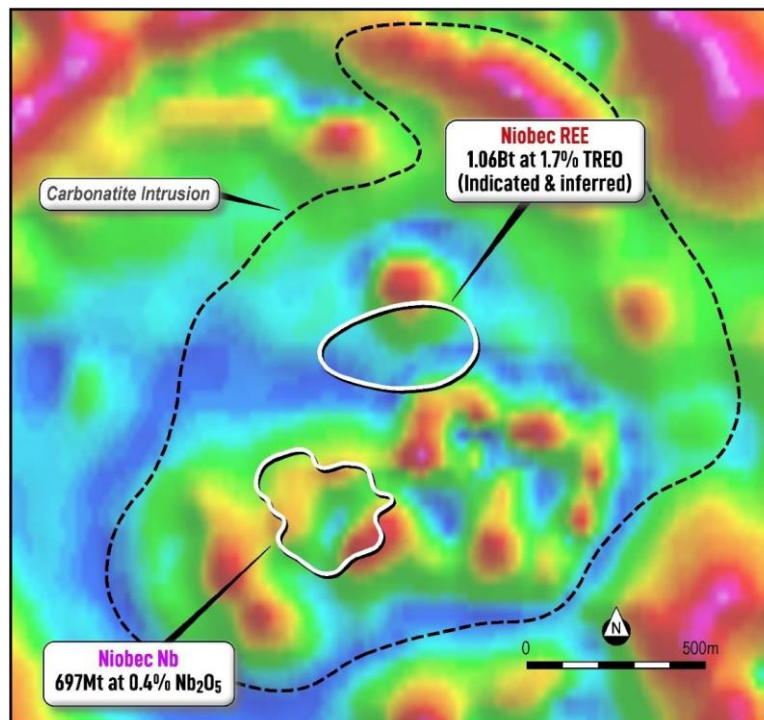
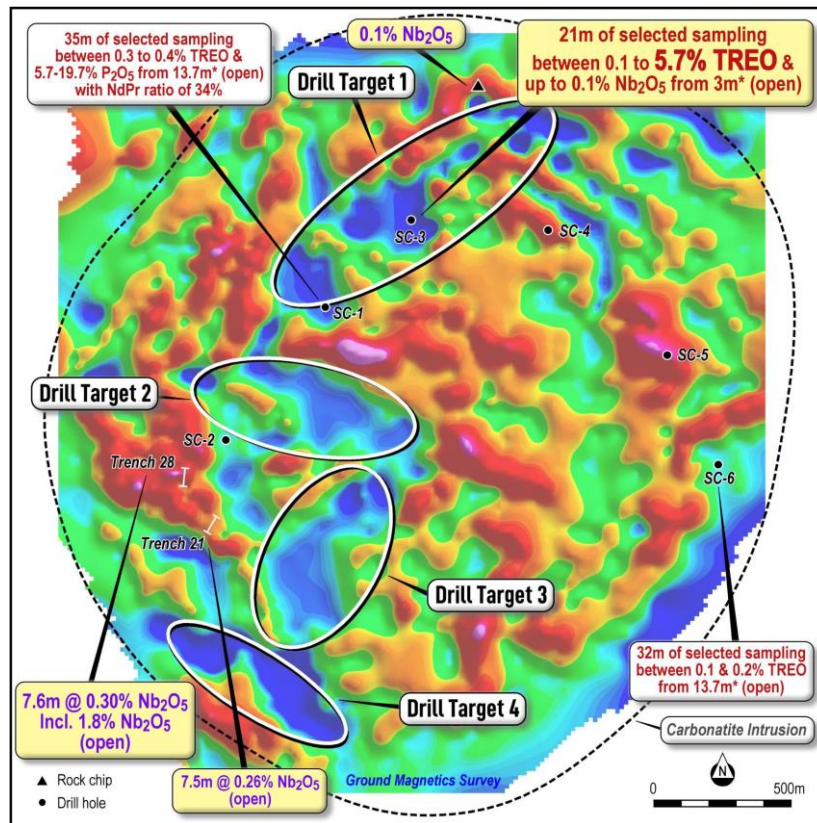

- Bindi Metals Limited (**ASX: BIM**, “Bindi” or the “Company”) is pleased to invite Shareholders to a Webinar with Company’s Executive Director, Henry Renou who will discuss the Schryburt Lake Project in terms of the exploration potential for Rare Earths and Niobium and its similarity to Niobec REE-Nb deposit in Canada.
- Analysis by Bindi geologists indicates several characteristics at Schryburt Lake similar to the Niobec REE-Nb deposit in Canada
  - **Four new large undrilled** “magnetic low” features **700m-900m** in length
  - Circular host **carbonate intrusive 3.8km by ~4.0km**
  - Evidence of high grade mineralisation to **5.7% TREO** within **magnetic low targets** and **1.8 % niobium** at Schryburt **never followed up**
- Geophysics and remote sensing work underway with planned summer field program to begin shortly, leading into maiden drill program planned to commence late July/ early August.
