# HERITAGE CLEARANCES RECEIVED FOR PRIORITY DRILL TARGETS

#### **HIGHLIGHTS**

- Heritage clearances have been received for areas covering priority lithium pegmatite targets at the Andover Project.
- Priority targets that are now accessible include AP0005, AP0006, AP0009, AP0010, AP0011 and AP0012.
- Track and drill pad establishment has commenced and two RC drilling rigs are being mobilised to site.
- Further heritage clearance surveys are planned.

Azure Minerals Limited (ASX: AZS) ("Azure" or "the Company") is pleased to announce that heritage survey clearances have been received for the next stage of the lithium-focused exploration drilling program at the Company's Andover Project (Azure 60% / Creasy Group 40%), located in the West Pilbara region of Western Australia.

Commenting on the heritage surveys Azure's Managing Director, Mr Tony Rovira said: "Receipt of the heritage clearances allows us to access the high priority lithium targets at the Andover Project.

"With the recent approval by the Department of Mines, Industry Regulation and Safety of the Programme of Work applications we now have in place all the environmental and heritage approvals required for the next stage of drilling at Andover. With two diamond core rigs already operating on site and two Reverse Circulation ("RC") drill rigs being mobilised, this is an exciting phase of our lithium-focused drilling campaign.

"The traditional owners of Andover and the Ngarluma Aboriginal Corporation were instrumental in completing the heritage surveys and I thank them for their help and cooperation."

### **Priority Targets**

As can be seen in **Table 1** below (ASX: 21 March 2023), in addition to the targets currently being drilled (AP0011 and AP0012), there are many other areas that have returned high grade surface sample results, resulting in APP0005, AP0006, AP0009, and AP0010 being high priority targets which will be the focus of diamond and RC drilling in the coming months.

Areas to the east and west of the current drilling at AP0011 / AP0012 will be drilled to test the continuation of the spodumene-rich bearing pegmatites intersected in early drilling (ASX: 15 March 2023 and 5 April 2023).

There remain further priority targets, including AP0001, AP0003, AP0004, AP0007, AP0008 and AP00013 (ASX: October 2022, ASX 20 January 2023, ASX 21 March 2023), which will follow once additional environmental approvals and heritage clearances are received.

## **Heritage Clearance Surveys**

Heritage clearance surveys were completed by the Ngarluma Aboriginal Corporation ("NAC", as representatives of the Native Title holders the Ngarluma People (Claim WCD2005/001). Surveys were conducted over seven days, with participants from the NAC, the NAC's heritage consultant and Azure.

Azure and the NAC have now completed six heritage clearance surveys at the Andover Project, and further surveys are planned for the second half of 2023.

## **Program of Work**

Program of Work ("PoW") approvals have now been received from the Department of Mines, Industry Regulations and Safety ("DMIRS") for 45.81ha of land over the priority target areas within Exploration Licence E47/2481 ("Exploration Licence") (**Table 2**). These PoW's provide Azure with the ability to construct tracks and drill pads, and conduct both RC and diamond drilling.




Figure 1: Andover Lithium Project area




Figure 2: Heritage Clearance Survey and PoW area
