SaaS Transport Management Contract Announced with Northline

Orcoda Limited (ASX: ODA) ('**Orcoda**' or '**the Company**'), the logistics optimisation and infrastructure services company, is pleased to announce that its wholly-owned subsidiary Orcoda Healthcare and Transport Logistics Pty Ltd have been awarded a SaaS supply deal with Northline Nomineeco Pty Ltd ('**Northline**'). The contract is in the process of being signed.

Northline is an Australian-owned, global logistics business with an industry-leading national freight network and an international reach into more than 100 countries. It has 18 depots across major cities and kev regional locations in Australia. with the ability and flexibility to tailor solutions to meet its customers' requirements and evolving market demands.

The Orcoda Logistics Management System ('**OLMS**') provide fleet optimisation and delivery management software solutions to support the management of Northline's commercial freight fleet. The software fully integrates with Northline's CRM, which enhances visibility and communication across depot staff, fleet drivers and management team. The OLMS in-vehicle app also provides Northline fleet drivers with value-add features such as enhanced driver safety, real-time updates, route optimisation and delivery authorisation.

The SaaS contract has an initial term of three (3) years. The Company's forecasted revenue for the initial term of the contract is circa \$900k, comprising monthly license fees and implementation and training fees that are subject to annual reviews. The contract substantially increases Orcoda's recurring software revenue.

Geoff Jamieson, Orcoda's Managing Director, said: "We are delighted that Northline has chosen Orcoda's software platform to support the management of its national freight network. We look forward to a long and mutually rewarding relationship."

Craige Whitton, Northline's Chief Executive Officer, said: "We have a sizeable and growing vehicle fleet servicing our logistics operations across Australia. After an extensive assessment of the alternatives we chose to partner with Orcoda, as we believe Orcoda's fleet optimisation and delivery management software solutions will add considerable value to the management of our fleet.
