Prodigy Gold Successfully Receives Two Exploration Grants under the Recourcing the Territory Initiative

HIGHLIGHTS

- The Hon. Nicole Manison Minister for Mining and Industry, announced today the results of the grants program under the Round 16 of the Geophysics and Drilling Collaborations (GDC) program funded by the Resourcing the Territory initiative at Prodigy Gold's office.
 - A record total of \$3.7M (GST-inclusive) of co-funding for exploration activities for 30 companies across the Northern Territory was announced¹
- Prodigy Gold is the successful recipient of two exploration grants in the Tanami North project area with the NT Government co-contributing a total of \$158,148. The successful programs are:
 - Tanami North Regional Scale Gravity Survey
 - covering a large portion of EL9250 that hosts the Hyperion gold deposit and EL31331 that hosts the Tregony gold deposit
 - Tregony Diamond Drillhole
 - the drilling of a single diamond core hole into the Tregony gold deposit to provide structural and stratigraphic context to the recently released mineral resource

Prodigy Gold NL (ASX: PRX) ('Prodigy Gold' or the 'Company') is honored to have welcomed the Northern Territory Minister for Mining and Industry, the Hon. Nicole Manison, to our Darwin office today to announce the results of the Round 16 Resourcing the Territory Exploration Grants. Prodigy Gold has been successful through the competitive process with two programs approved for co-funded exploration, both located on the Tanami North project, which will be a key focus for the Company over the coming field season.

Both co-funded programs will expand Prodigy Gold's understanding of the Tanami North project area and aid more detailed exploration planning moving forward. The two programs are further detailed below.

Tanami North Regional Gravity Geophysical Survey




Figure 2 Proposed gravity stations for Tanami North with current regional 4km gridded gravity intensity as background

Prodigy Gold has recently completed a detailed gravity survey around the Hyperion gold deposit, which has identified several structural trends that host mineralisation not identified in earlier airborne magnetic surveys. The planned regional ground-based gravity survey of the Tanami North project will extend from the southern boundary of EL9250 up to the northern boundary of EL31331 (Figure 2). Approximately 550 recording stations will be surveyed on an 800m x 800m grid over this area. This will be reduced to a tighter 400m x 400m grid for a total of around 940 recording stations over the interpreted location of the Suplejack Shear Zone ('SSZ'). The survey will provide high resolution data over the Hyperion and Tregony mineral resources and will assist in identifying potentially new mineralised structures in this known gold camp.

The program, if successful, has the potential to open up new areas for further exploration, targeting potentially mineralised structures adjacent to the SSZ and within the Killi Killi Formation, which is mineralised in other areas such as the Groundrush Gold Deposit in the immediately adjacent Central Tanami Project Joint Venture ("CTPJV") between Tanami Gold NL and Northern Star Resources Limited.

Tregony Diamond Drillhole

The maiden mineral resource for the Tregony gold deposit was released in February this year² highlighting the potential for the project. Prodigy Gold now has a single diamond core hole, to a depth of around 350m, approved as part of the Round 16 Resourcing the Territory co-funding grants.




Figure 3 Long Section of Tregony mineralised system showing proposed location of diamond hole¹

The single deep diamond hole is designed to test/extend mineralisation down plunge of the current mineral resource (Figure 3), while providing structural and stratigraphic context to mineralisation in an area with no previous drilling. The co-funded diamond hole will be used to better understand the local structural controls on the stacked vein system of the Tregony mineral resource, allowing for better targeting of higher-grade zones within this deposit.

This diamond hole is likely to be drilled before the end of the 2023 field season.




Figure 4 Mineralisation for Tregony deposit showing the stacked veins¹

- joint ventures to expedite discovery on other targets




Figure 5 Prodigy Gold major project areas
