archTIS Awarded \$241,200 Contract with Babcock Australia for Kojensi

The contract can be terminated in the first 30 days by either party through written notice, termination outside of this period will incur full costs for the term.

Babcock is a Defence, Aviation and Critical Services company that operates across the Marine, Aviation and Land Sectors. Babcock employs more than 1,600 people in Australia and New Zealand. Babcock has selected Kojensi for their extranet service to share information securely across their supply chain and with their clients. Babcock Australasia is part of Babcock International Group, the global aerospace and defence company.

Daniel Lai, archTIS Managing Director, said: "Babcock Australia is a well-recognised global Defence prime and their selection of Kojensi validates the value it offers to quickly deploy a secure platform for sensitive information exchange. It is an important milestone in our continued drive to make Kojensi the preferred platform for the secure sharing and collaboration of classified information between partners across Defence and the supply chain."
