Solis Minerals is a Latin American battery mineral-focused mining exploration company. The Company owns a 100% interest in the Borborema Lithium Project in NE Brazil covering 24,800 ha, and has recently executed an option to acquire 100% of the Jaguar Lithium project in Bahia state Brazil. In addition Solis and holds a 100% interest in 32,000 ha of combined licences and applications of highly prospective IOCG (iron oxide copper/gold) and porphyry copper projects in southwestern Peru within the country's prolific coastal copper belt — a source of nearly half of Peru's copper production.
