SRG Global Secures Specialist Facades Contract at One Circular Quay valued at ~\$40m

The contract is with Lendlease for the design and supply of specialist engineered curtain wall facades at the One Circular Quay project located at Sydney's harbour-front Circular Quay Precinct. The contract will start immediately and is expected to be completed in 2025.

The ~\$3b One Circular Quay project will incorporate two high rise towers. The 61 level Tower A is predominantly high-end luxury apartments and penthouses with uninterrupted views of the Sydney Harbour, Opera House and Harbour Bridge. The 26 level Tower B will be a 220-room luxury Waldorf Astoria hotel, marking the entry of Hilton's iconic luxury brand into Australia.

SRG will collaborate with Lendlease to implement best practices and innovations in sustainable design, construction, health and wellbeing, targeting both a 6 star Green Star rating and a Platinum WELL Building Standard rating.
