UPDATE TO PRICING OF THE OPTIONS UNDER THE ENTITLEMENT OFFER

Norwood Systems Limited (ASX:NOR) advises that in consultation with ASX and pursuant to ASX Listing Rule 7.11.2, the Company has decided to reduce the issue price of the new options under the non-renonceable pro rata entitlement issue from \$0.0025 to \$0.002 per new option (**New Issue Price**). The issue price of the new options under the placement remains the same, being \$0.0025 per new option. As a result, the total proceeds of the entitlement offer and the placement will be reduced by approximately \$20,221 from \$101,104 to \$80,883 (assuming no new shares are issued and no convertible securities are converted). A replacement prospectus reflecting the New Issue Price has been lodged with ASIC.
