COMPLETION OF UNMARKETABLE PARCEL SHARE BUYBACK

Hygrovest Limited (ACN 601 236 417) (ASX: HGV) ("HGV" or the "Company") is an Australian-listed specialist investment company which concentrates on producing capital growth for shareholders over the medium term from investments in listed and unlisted equities and debt securities.

Completion of HGV Unmarketable Parcel Share Sale Facility

On 28 April 2023, HGV announced details of an off-market share buy-back facility ("Buy-Back Facility") to buy-back all the shares held by shareholders who held unmarketable parcels of shares in HGV's register of members as at 5.00pm (Perth time) on 27 April 2023 (the "Record Date") ("Eligible Shareholders").

In accordance with the terms of the Buy-Back Facility, Eligible Shareholders had until 5.00pm (Perth time) on 16 June 2023 (the "Closing Date") to opt-out of the Buy-Back Facility or increase their shareholding to more than a marketable parcel ("Closing Time"). Eligible Shareholders that did not exercise either of these options by the Closing Time had their HGV shares bought back by HGV at \$0.052 per share ("Buy-Back Price").

A total of 19,643,383 HGV shares have been acquired under the Buy-Back Facility at the Buy-Back Price and have been cancelled for a total consideration of \$1,021,464 in accordance with the Corporations Act 2001 (Cth). As a result, HGV now has 210,310,602 ordinary shares on issue. In accordance with the requirements of ASX Listing Rule 3.8A, enclosed is a copy of the Form 484 lodged with ASIC.

Eligible Shareholders whose shares were bought back under the Buy-Back Facility will have their proceeds remitted to them and will be sent documentation advising them of the number of shares sold and the amount of proceeds remitted.
