### NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

Norwood Systems Ltd (Norwood or the Company) (ASX: NOR) has completed an allotment in the Company of 2,300,000 fully paid ordinary shares in the capital of the Company (Shares). 2,300,000 shares were issued on 23<sup>rd</sup> June 2023 on conversion of 2,300,000 options exercisable at 2.4 cents each with an expiry date of 31 December 2023. The options were exercised by Balmain Resources Pty Ltd, a company in which Director, Dr John Tarrant is a sole director and sole shareholder. These Shares are included in an Appendix 2A lodged on 23<sup>rd</sup> June for 2,450,000 Shares.
