

## ISSUE OF SHARES AND CLEANSING NOTICE

Further to the ASX announcements on 5 April and 1 June 2023, Midas Minerals Ltd ("Midas", or "the Company") (**ASX: MM1**) has issued 2,200,000 fully paid ordinary shares ("Shares") to Gold Terra Resource Corp. as part of the Stage 1 Earn-in for the Yellowknife Lithium Project in Northwest Territories, Canada.
