

Dropsuite Vesting of Performance Rights

4 July 2023: Global cloud backup and archiving software provider Dropsuite Limited (ASX: DSE) ("Dropsuite" or the "Company") confirms the Board of Directors have resolved the issuance of 2,846,667 fully paid ordinary shares related to the vesting of performance rights granted under the 2022 Employee Long Term Incentive Plans (LTIP) for eligible employees following satisfaction of the below hurdles:

- Employees have been employed for a period of 12 months from the date of grant; and
- Share price achieved a 30-day volume weighted average price of at least AUD\$0.25 for a minimum of thirty days.
