WITHDRAWAL OF INTENTION TO MAKE A PARTIAL TAKEOVER BID

Athena Resources Limited (ASX:AHN) (Athena) advises as follows:

On 15 June 2023 Athena announced the receipt of a notice from Adroit Capital Investments Pty Ltd (Adroit) that it proposed to make a conditional off-market partial takeover bid for 20% of the Company's Shares it and its associates did not hold (Partial Takeover Bid).

Following the support shown by Shareholders for existing management at the recent General Meeting called by Adroit, with over 70% of votes rejecting Adroit's resolutions, (as announced to the ASX on 28 June 2023), the Company has received a letter from Adroit's solicitors advising that Adroit withdraws its notice and will not be making a Partial Takeover Bid.

A copy of this letter is attached.

Adroit's intention in calling the Meeting was to refresh the Board.

The Company has been working on strengthening the skills and capability of the Board and Management for some time, reflected in the recently announced appointments of Terry Weston and Jeff Swingler as of 1 July 2023.

Withdrawal of intention to make partial takeover bid

As a result of the outcome of the Meeting, the conditions of the Offer as set out in the Notice have not been met.
