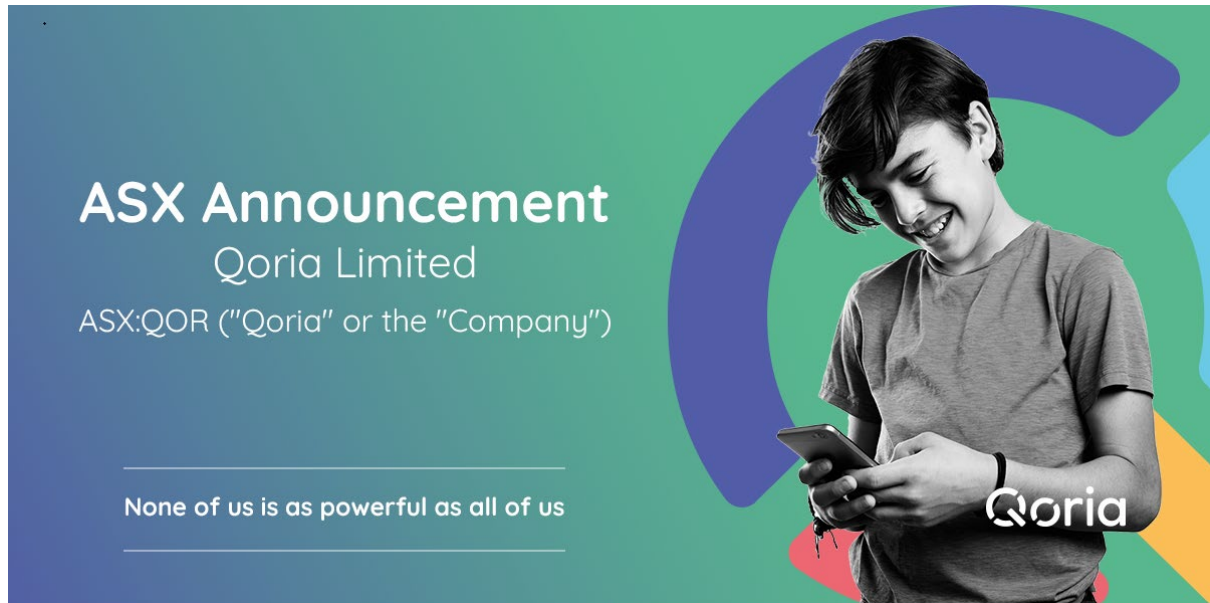




OPTION EXERCISE AND CLEANSING STATEMENT
