## **SECTION 708A NOTICE – ISSUE OF SHARES**

Sunshine Metals Limited (ASX:SHN, “Sunshine Metals”, “the Company”) provides this notice to ASX under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) in relation to the issue of 1,000,000 fully paid ordinary shares at \$0.015 per share (**Shares**) in the capital of the Company. The issue of the Shares to a sophisticated investor was approved at the Company’s general meeting held 23 June 2023 and without disclosure under Part 6D.2 of the Corporations Act.

  - (i) the provisions of Chapter 2M of the Act, as they apply to the Company; and
  - (ii) section 674 of the Corporations Act, as it applies to the Company,
- (c) as at the date of this notice, there is no information that is no “excluded information” as defined in of sections 708A(7) and 708A(8) of the Corporations Act which is required to be disclosed by the Company.
