Cleansing Notice

Notice Under Section 708A(5)(e) of the Corporations Act

On 12 July 2023, Celsius Resources Limited (ASX:CLA) (Celsius or the Company) issued a total of 2,500,000 fully paid ordinary shares on exercise of 2,500,000 unlisted options over shares, each option exercisable at \$0.012, expiring on 4 August 2023. The issue of shares was under an exception to the Company's Listing Rule 7.1 capacity.

The shares issued under this announcement have been without disclosure to investors under section 708A(5) of the Corporations Act 2001 (Cth) (Corporations Act).
