Request for Trading Halt

Pursuant to ASX Listing Rule 17.1, DUG Technology Ltd (ASX: DUG) (the “**Company**”) requests an immediate trading halt be granted by ASX in respect of its ordinary shares from the commencement of trading today, 18 July 2023.

In accordance with ASX Listing Rule 17.1, the Company provides the following information:

- (a) The trading halt is requested pending the release of an announcement by the Company in relation to funding arrangements for the construction of a new data centre in Geraldton (“**Announcement**”).
- (b) The Company requests that the trading halt remain in place until the earlier of the release of an Announcement, or the commencement of trading on 20 July 2023.
- (c) The Company is not aware of any reason why the trading halt should not be granted.
- (d) The Company is not aware of any other information relevant to this request.
