Notice received under section 249D of the Corporations Act and Shareholder Update

Section 249D Notice

Firefinch Limited (ASX:FFX) ("Firefinch" or the "Company") advises in accordance with ASX Listing Rule 3.17A that, on 18 July 2023, it received a notice ("Notice") pursuant to section 249D of the Corporations Act 2001 (Cth) ("Corporations Act") from each of the shareholders listed in Annexure A below (together the "Convening Shareholders"). The Convening Shareholders collectively hold approximately 6% of the fully paid ordinary shares of the Company.

The Convening Shareholders have requested the directors of the Company call and arrange to hold a general meeting for the purpose of considering the following resolutions (together the **Proposed Resolutions**):

- 1. the removal of Mr Brett Fraser, Mr Mark Hepburn and Mr Bradley Gordon as directors of the Company with immediate effect; and
- 2. the appointment of Mr Garry Peter Lougher and Mr Gareth John Edwards as directors of the Company with immediate effect.

The Company will undertake the necessary steps to convene a general meeting in compliance with the Corporations Act. Further details of the general meeting, together with the Board's recommendations, will be circulated to shareholders in due course along with the Board's fulsome response.

The Board (including Mr Scott Lowe, who is not the subject of the Notice) notes:

- 1. the Board is unanimously of the view that the Proposed Resolutions are not in the best interests of the Company or its shareholders;
- 2. the Board intends to recommend that shareholders vote **AGAINST** the Proposed Resolutions and intend to vote their own shares **AGAINST** the Proposed Resolutions;
- 3. each of Mr Brett Fraser, Mr Mark Hepburn and Mr Bradley Gordon are independent directors of the Company and have provided significant leadership to the Company since their appointment;
- 4. taken together, each of Mr Brett Fraser, Mr Mark Hepburn and Mr Bradley Gordon have the appropriate mix of knowledge, skills and experience to complete the final stages of the Company's strategy to deliver superior value and liquidity to Firefinch shareholders through the Process; and
- 5. the Board is concerned that the Proposed Resolutions, if implemented, would be a significant destabilising event at a time of critical importance to the future of the Company as it realises its strategy in relation to the Process.

The Company has reminded the Convening Shareholders of their obligation to provide disclosure under section 671B of the Corporations Act if they begin to have a substantial holding in the Company.
