8.8.1	Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
	Answer: The Company expects to have negative operating cash flows for the time being as it is in the exploration stage and does not generate any substantial income at this time. Substantial drilling and metallurgical work was performed in lead up to the release of the Maiden Mineral Release Estimate (MRE) on 11 July 2023, resulting in approximately \$1.6 million of exploration and evaluation expenditure during the quarter ended 30 June 2023. Given the completion of the recent work in relation to the MRE, it is therefore expected that, whilst the Company will continue to have negative operating cash flows, the negative operating cash flows in coming quarters will be at a lower level.
