Subsequent to the end of the quarter, on 21 July 2023, the Company's shareholders approved a Secured Convertible Note Facility with Reforme Resources Pty Ltd as trustee for the Reforme Resources Unit Trust of A\$2.5 million with drawdown at the election of the Company. Each Convertible Note has a face value of \$1.00, which is repayable, with interest at 7.5% per annum, upon the date which is 36 months after the first drawdown of the Facility (or such later date as agreed by the parties).

Answer: Yes, the Company expects to have negative operating cash flows for the time being as it is in the exploration stage and does not generate income.

Answer: Subsequent to the end of the quarter, on 21 July 2023 the Company's shareholders approved a \$2.5m Convertible Note Facility, which the company has available to draw down upon to fund operations. In addition the Company continues to assess its options with regards to raising the additional funds.
