QUARTERLY ACTIVITY REPORT AND APPENDIX 4C

4DS Memory Limited (ASX:4DS) (**4DS**) (the **Company**), is pleased to provide its Quarterly Activity Report and Appendix 4C for the Quarter ended 30 June 2023.

Company Update

On 19 June 2023 the Company announced that HGST, a subsidiary of Western Digital Corporation, had now signed the 10th consecutive twelve (12) month renewal of its joint development agreement (**JDA**) (**Agreement**) with 4DS ahead of the 30 June 2023 renewal date.

As reported on 26 April 2023 the Company significantly enhanced its test capabilities and re-tested the Third Platform Lot in preparation for the Fourth Platform Lot.

Subsequent to 30 June 2023 on 3 July 2023 the Company advised the Fourth Platform Lot had been successfully manufactured and shipped from imec to Fremont, California. The Lot is currently undergoing extensive analysis utilising the enhanced test capabilities with results to be announced upon completion.

Previous guidance for results remains Q3 2023.

COVID-19 Update

Currently, there are no COVID related restrictions significantly affecting the Company's operations in the USA or Belgium. All 4DS employees are fully vaccinated.

Financial Review

As of 30 June 2023, the Company held cash of \$5.600 million, compared to \$6.521 million as of 31 March 2023. Net cash of \$0.883 million was used in operating activities during the quarter, a decrease of \$1.055 million when compared to \$1.938 million used in the March quarter. The main difference, when compared to the previous quarter, was a reduction in R&D expenditure due to only one payment being made to imec in the June quarter compared to three payments to imec during the March quarter.

In item 6 of the Appendix 4C cash flow report for the quarter, payments to related parties of approximately \$167k represent salary and bonus paid to the Interim Executive Chairman and Director fees paid to the Non-Executive Directors, including advisory fees paid to the US based Non-Executive Director.
