### **Stockpiles**

In Kingsgate's Quarterly Activities Report released on 31 July 2023, the Company reported an upgrade to the stockpiles after the completion of a thorough stockpile density assessment. For the purposes of clarity, this brings to the total stockpile as of July 2023 to **7,626,531 tonnes**, which gives Kingsgate **more than 2.5 years of mill feed** at the current rate.
