

Issues of Shares

Complii FinTech Solutions Limited (**Complii** or the **Company**) (CF1.ASX) advises that the Company has issued 500,000 fully paid ordinary shares (**Shares**) upon the exercise of unquoted performance rights that vested in accordance with the Company's Incentive Performance Rights Plan.

Separately, the Company has issued 698,290 Shares to non-executive director, Nick Prosser under the Director Fee Plan in lieu of cash payment for director's fees owed to Mr Prosser for the period from 1 July 2022 to 30 June 2023. An additional 52,250 Shares have been issued to Mr Prosser for the period from 1 January 2022 to 30 June 2022 as his director's fees increased with effect from 1 January 2022. Shareholder approval was obtained for the issues of Shares to Mr Prosser at the Annual General Meeting held on 26 October 2021.

Additionally, the Company has issued 1,000,000 Shares in lieu of cash payment for services provided by a consultant. The Shares have been issued under the Company's 15% placement capacity under Listing Rule 7.1.
