Re: Form 604 - Correction

I refer to ASIC Form 604 *Notice of change of interests of substantial holder* (the **Form**) dated and lodged yesterday 1 August 2023 in respect of interests held by Netwealth Superannuation Services Pty Ltd and associated entities referred to in the Form (**Substantial Holders**) in My Rewards International Limited ACN 095 009 742 (**MRI**).

Errors have since been identified in the Form, which has required the following corrections:

- *Paragraph 1 (Details of substantial holder)* – there was a change in the interests of the Substantial Holders on 19 July 2023;
- *Paragraph 2 (Previous and present voting power)* – on 19 July 2023 the Substantial Holders present votes was 33,303,693 and the voting power was 8.62%;
- *Paragraph 3 (Changes in relevant interests)* – the change in relevant interests was an increase in relevant interests as set out in Annexure A;
- *Paragraph 4 (Present relevant interests)* – on 19 July 2023 the class and number of securities of the Substantial Holders was 33,303,693 fully paid ordinary shares and the number of votes of the Substantial Holders was 33,303,693; and
