

# COMPLETION OF STRATEGIC FOURACRES HEAVY MINERAL SANDS PROJECT ACQUISITION, WA

# High-value mineral assemblage enhances Governor Broome Project

Further to its announcement dated 13 July 2023, Astute Metals NL (ASX: ASE, "Astute" or "the Company") is pleased to advise that it has completed the 100% acquisition of the Fouracres tenement (Tenement No. R70/22), located adjacent to its Governor Broome Minerals Sands Project in WA. All conditions precedent to the transaction have been fulfilled and ownership has now passed to Astute's wholly owned subsidiary, Governor Broome Sands Pty Ltd.

#### **Background**

The Governor Broome Heavy Mineral Sands Project is a largely de-risked resource development project in the south-west of Western Australia with substantial total JORC Mineral Resource of 127Mt of Mineral Sands grading 4.3% Heavy Minerals<sup>1</sup>. An updated table of project Mineral Resources is provided below.

In preparation for conducting a Q1 2024 Scoping Study for the Governor Broome Project, the Company is actively advancing the following pre-requisite works and expected timing of market update is as follows:

- Mineral assemblage analysis for the recent Jack Track Deposit in-fill drilling program Q3 2023
- Marketing study for mineral sands products Q3 2023
- Bulk Sample Testwork Results for the Jack Track Deposit Q3 2023
- Mineral Resource Estimate Update Q4 2023
