SRG Global Secures Specialist Facades Contract for Multiplex's Nine The Esplanade Project valued at ~\$25m

Highlights:

- **SRG Global has secured a contract with Multiplex in Western Australia valued at ~\$25m**
- **The contract is for Specialist Facades works at Nine The Esplanade located in the Elizabeth Quay precinct of Perth**
- **Continues SRG Global's longstanding relationship with Multiplex**

SRG Global Ltd ('SRG Global' or 'the Company') (ASX: SRG) is pleased to announce that it has secured a specialist facades contract in Western Australia valued at ~\$25m.

The contract is with Multiplex on behalf of Brookfield Properties and CBUS Property, for the design, supply and installation of specialist engineered curtain wall facades at Nine The Esplanade project located at Elizabeth Quay in the Perth CBD. This project is adjacent to our recently completed One The Esplanade project for Multiplex. The contract will start immediately and is expected to be complete in 2024.

The ~\$500 million development will comprise a 19-storey Premium Grade office building of circa 32,500 square metres with views across Elizabeth Quay and the Swan River. Reflecting the latest in environmentally sustainable workplace design, this next-generation office tower is targeting a 6 Star Green Star rating, 5.5 star NABERS Energy rating and IWBI WELL Gold Core certification.

David Macgeorge, Managing Director, commented: "We are very pleased to be selected to provide specialist facades for this significant project in Western Australia. This project award continues our longstanding and trusted relationship with Multiplex having recently completed the facades and structures package for the One The Esplanade project and the recently commenced ECU City Campus development with Multiplex."
